1. Clients are individuals.
2. Subject – participation in the II International Competition of Young Pianists "New Generation" by providing video recordings of 2-3 different works, one of which is a mandatory piece. Mandatory plays are available for download from the website <http://ng-artist.ru> , and also by the link:

3. Applications for participation are sent by e-mail info@ng-artist.ru. A sample application for participation in the competition is in the Regulations on the II International Competition of Young Pianists "New Generation" on the website <http://ng-artist.ru>.
4. The competition is held in correspondence and in-person nominations.
5. The correspondence nomination is held in one round from November 01, 2022 to March 02, 2023 by listening to the jury of video recordings of competitive performances and awarding diplomas of laureates and diploma holders of the competition, diplomas are sent to participants in electronic form.
6. The full-time nomination is held from November 01, 2022 to March 02, 2023 in Petrozavodsk (Karelia) in 3 rounds:
 - Qualifying round;
 - Solo performances;
 - Performances with the orchestra.
7. The contract is considered concluded from the moment of acceptance of the offer – full payment of the registration fee.
8. The cost of the registration fee, the program and the format of the competition are published in the Regulations on the II International Competition of Young Pianists "New Generation" on the website <http://ng-artist.ru>.
9. Customers pay the registration fee by bank transfer.
10. Autonomous non-profit organization for the development of education, culture and Art "Aeolian Harp" and clients do not sign acts. Payment confirms the quality of services.
